Brunswick Academy Enrollment Contract

Brunswick Academy agrees to enroll _____ into Grade _____ for the 2020-2021 school year and provide the educational program and other services as prescribed for that grade.

The undersigned agrees to enroll the student and agrees to be financially responsible for required tuition and any fees as described below.

- **Registration - A non-refundable \$200.00 registration fee is required annually per family with your registration form**
- An additional penalty of \$100.00 per family will be charged for registrations after April 1st for returning patrons.
- **Tuition** - Tuition covers the cost of instruction, student insurance, and general bus transportation when feasible.
- **Discounts** - A 25% tuition discount is offered for the third child and a 50% discount for the fourth enrolled in the same family. The discount is applied first to the youngest child enrolled. Additional discounts are applied to the next oldest children enrolled. This discount does not apply if other tuition reductions are applied.
- **Payment** - Tuition is due and payable on or before June 30th. A statement will NOT be sent. All tuition must be paid before your child/children can attend school. This deadline is set to ensure the integrity of the budget. Tuition can now also be paid by personal Credit Card. (Please note a 5% processing and handling fee will be added).
- **Loss of Interest Penalty** - The Academy utilizes interest from the total tuition of all patrons. For this reason, tuition not received by July 1st will be assessed an additional charge of \$200.00 per child.
- **School Loan Plan** - The Academy will be processing loans in house for the '20-'21 school year. Should you choose to use this alternative, please check the appropriate blank on the registration form and school loan form. You will then receive pertinent information at a later date from our finance office regarding your loan.
- **Overdue Accounts** - Students enrolled through the school bank plan will be subject to dismissal should accounts be reported by the bank as past due.
- **Refunds** - In the event a child is no longer enrolled at the Academy, for whatever reason, a request for a tuition refund can be made in writing to the Board of Directors for its consideration. Refunds are not guaranteed, but, if granted, will be made based on the semester the child was last enrolled. A withdrawal fee of the first semester tuition will be required if a refund is requested prior to the beginning of school. If there is a discrepancy between the date of withdrawal and the date of release from the bank, the parent will be responsible for any and all carrying and/or closing costs.

I understand that in signing the Enrollment contract for the upcoming academic year, I am agreeing to accept the rules and regulations of the School as stated in the current handbook. I understand that if my account is delinquent the School will follow the Board approved Overdue Accounts Policy for the collection of my account. Additionally, end of the school year academic records and grades may not be released and my child may not be eligible for re-enrollment in the following school year. If this account is referred to an attorney for collection, the undersigned promises and agrees to pay all collection costs including attorney fees of 33 1/3% of the principal amount due and owing when turned over for collection and further agrees to pay interest on the unpaid balance at the rate set forth herein from the date such monies become due and owing.

I understand that if I am using the Bank Plan that I shall fully satisfy my financial obligation to that bank pursuant to terms thereof. Should the School incur any financial loss because I fail to keep my obligations under the Bank Plan then I expressly agree to reimburse the School for that financial loss, including all attorney's fees, court costs, loss of interest on the deposit, and any other collection costs. Furthermore, I expressly agree that if I am delinquent in the payment of any financial obligation to the School (tuition, Bank Plan, lunch account, library fees, athletic fees, etc.), the School shall withhold from release all student records until such time as the financial obligation is satisfied.
